During this interactive course, participants will learn the risk mitigation techniques, fire protection cost-benefit analysis and fire risk management; the classification and identification of hazardous materials; the storage and handling requirements for hazardous materials; the causes and types of explosions, explosion venting and suppression techniques; the explosion-proof equipment and code requirements for explosion hazard; the wildfire risk assessment and mitigation, integrating security and fire protection systems and accessing control and fire door management; the emergency power and lighting systems, principles of fire investigation and legal and regulatory aspects of fire protection; preparing fire incident reports, maintaining accurate fire protection records and documenting for inspections and tests; and the legal requirements for incident documentation.
