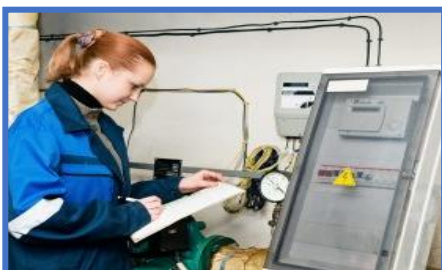

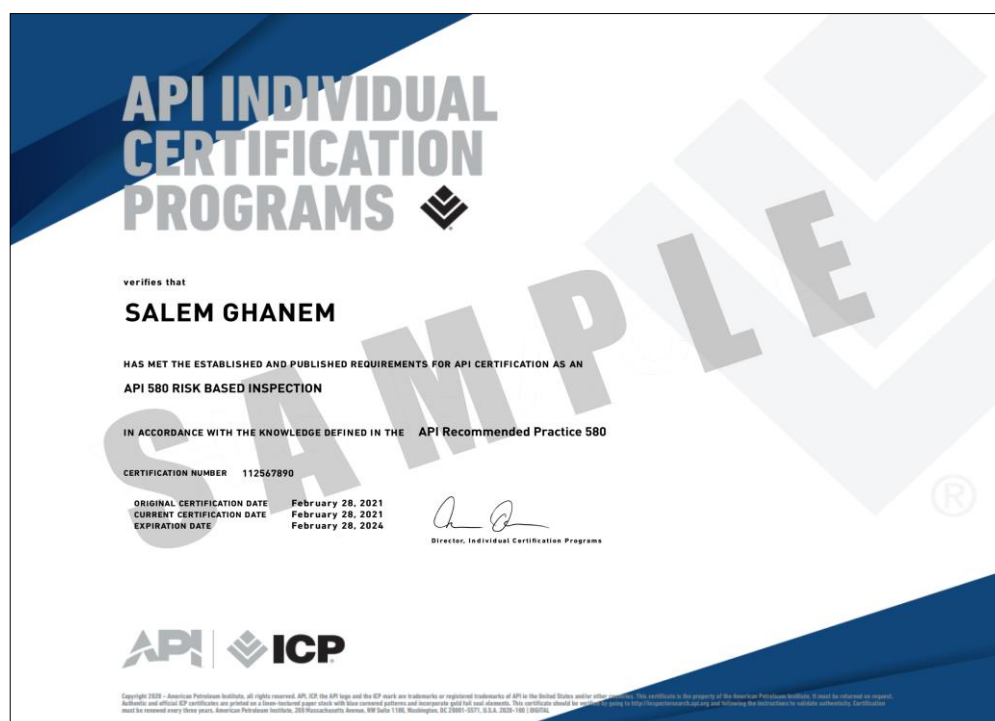

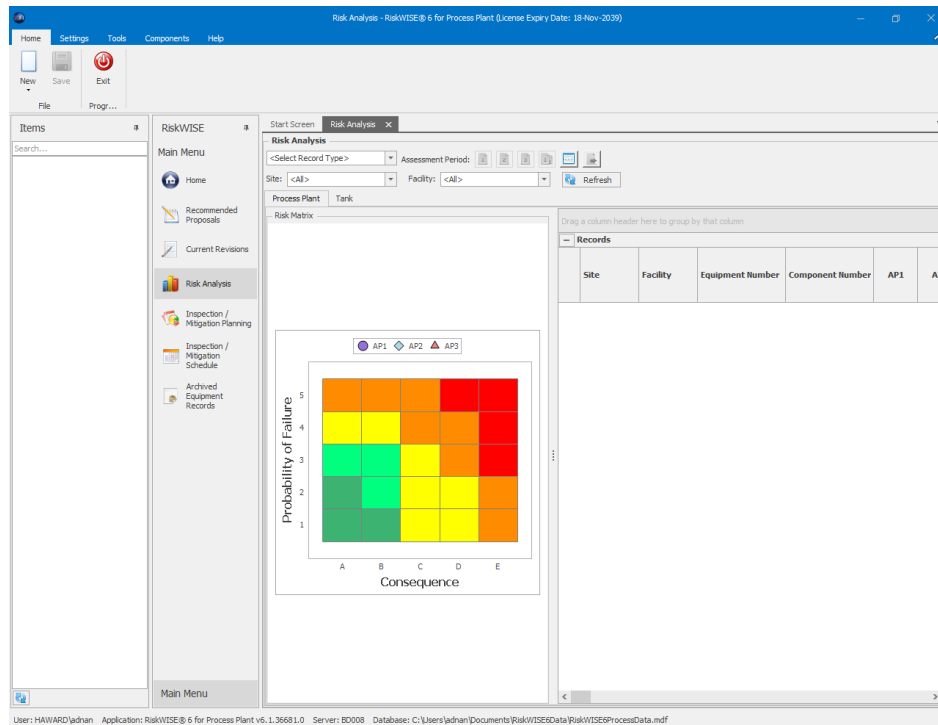
MOCK Exam

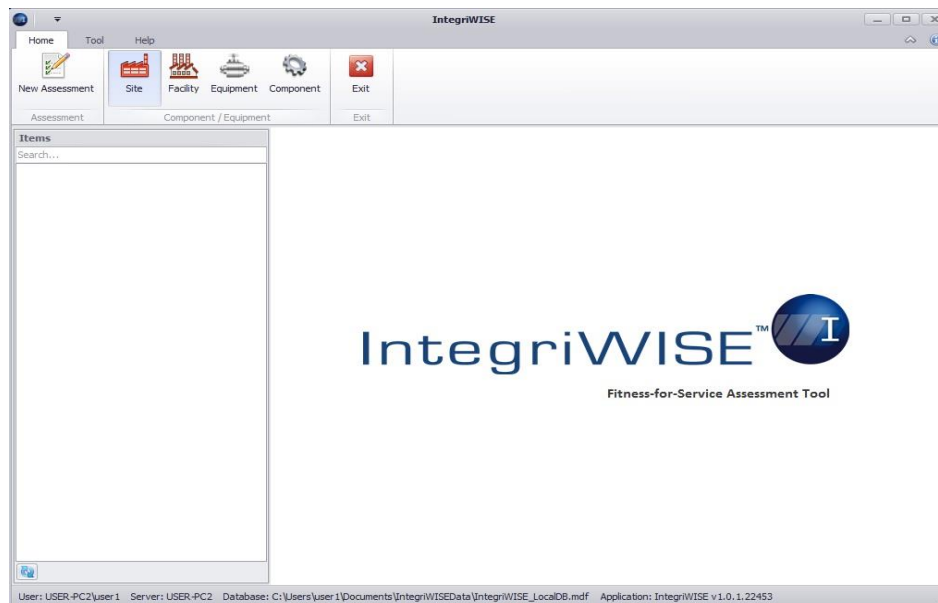


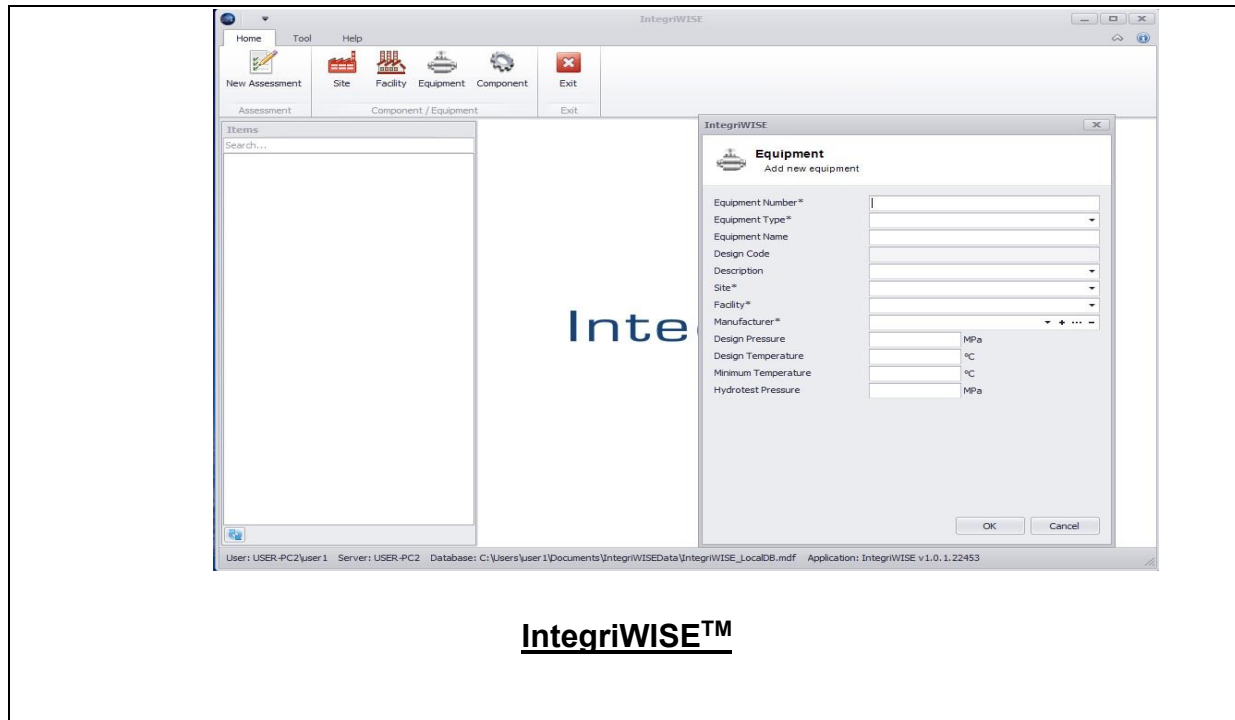
